Pursuant to OCGA 21-5-34 (c) (2) (c), during the period of time between the last report due prior to the date of any state-wide primary or state-wide election for which the candidate is qualified and the date of such primary or election, all contributions of \$1,000.00 or more must be reported within 48 hours of receipt to the location where the original disclosure or committee was filed and also reported on the next succeeding regularly scheduled campaign report.

Please be advised that reports not filed within the guidelines as stated above are subject to a late fee charge by the State Ethics Commission.
