Please review the Campaign Contribution Disclosure Reports you filed for September 2008, October 2008 and December 2008, making sure all entries are correct. You may visit the State Ethics website: for any additional forms you may need.

www.ethics.ga.gov/references/publications.aspx. Please review the options, choose the forms needed to file the report for that filing year. For example: 03/2008 forms are on line #9, (be careful not to print form on 9-A, that form is for Statewide Executive Offices). To amend 2006- 2007 years, line #16. forms for 2005 & earlier years line #20.

As you know, any candidate seeking elective office at the county or municipal level, upon having raised or spent a minimum of \$10,000 in an election cycle, shall be required to electronically file campaign contribution disclosure reports with their local filing office. Candidates not meeting the \$10,000 threshold do not have to file electronically, but are permitted to do so. The e-mail address is: voterreg@co.dekalb.ga.us. **When filing electronically, the paper report is not required.**

Please be advised that reports not filed within the guidelines as stated above are subject to a late fee charge by the State Ethics Commission.
